

Exhibits and Collections: Minnetrasta brings to East Central Indiana experiences that could not be had anywhere else in our community. In 2021, Minnetrasta hosted eight traveling and partner exhibitions in five exhibition spaces, in addition to several Minnetrasta original exhibitions in various spaces across the forty-acre campus. Some of the exhibits that excited visitors in 2021 included: "FIX: Heartbreak and Hope Inside Our Opioid Crisis," a partner exhibit developed by the Indiana State Museum, and "Framed: Step into Art," a traveling exhibition developed by the Minnesota Children's Museum. Minnetrasta also produced two in-house art shows highlighting the work of adult avocational and professional artists from Indiana. Continued on Schedule O.

As the home of the Ball Jar, Minnetrasta continues to serve as a legacy site and gathering place for East Central Indiana. Visitors come to explore, recharge, and connect. In 2021, more than 64,000 visitors found solace on our grounds, through outdoor events and exhibits adapted for a year of social distancing and mask-wearing. Families attended adapted versions our signature events like Faeries Sprites & Lights and Enchanted Luminaria Walk. We opened an expansion to our 2020 Bob Ross Experience including a painting workshop and gallery space on the second floor of the LL Ball home. We continued to offer online offerings alongside returning in person experiences to allow our community to attend programs like Tea and Talk and Exhibit Openings according to their comfort level.

Minnetrasta improves the quality of life for East Central Indiana by offering a beautiful location in the middle of Muncie. With a six-acre nature area, 23 acres of themed and historic gardens, and a stretch of the White River Greenway, Minnetrasta serves as green space for the community. This space continued to provide invaluable respite to our community during 2021 as the visitors sought ways to get physical and find mental relief from life stresses caused by both personal and national factors like the pandemic, economics, and political pressures. We provided assistance to community groups unable to connect in person with technical assistance to move their programs on line allowing us to continue to host many important community meetings and events.

These funds are invested and held for the intended purpose until they are released from restrictions.

Annual and quarterly reviews are conducted for each paid staff position and merit raises of 0% to 4% may be awarded.
